

Department of Mississippi Marine Corps League  
Convention Meeting Minutes  
26 Apr 2025

Meeting was called to order at 0830 by Department Commandant. There were a total of 28 members present, including Department of Mississippi members and guests.

Commandant led members in Pledge of Allegiance. Opening ceremony was conducted.

A memorial service was conducted honoring fallen members. Each fallen member's name was read and candles were lit in their memory.

Commandant introduced visiting dignitaries from National, Division, and neighboring Departments.

A quorum, as defined by Section 420, Department of Mississippi bylaws, was present.

Officer Reports

Adjutant: Motion was made and seconded to waive reading of minutes from last Department meeting since the 13 Jan 2024 meeting minutes have been posted to the Department website. Motion passed without objection.

Paymaster

Reported that as of 21 Apr 2025 the Department had a total of \$30,159.48: \$2,009.56 in the regular account, \$452.89 in the veterans service account; \$21,864.36 in the 250th Marine Corps Birthday Ball account; \$225.00

in the disaster relief account; \$146.00 in the children's hospital account, \$600.00 in the disaster relief account, \$400 in the scholarship account, and \$5,861.97 in the YANKY 72 account. There is also a negative \$800.40 balance in the foundation fund. Motion was made and seconded to accept the Paymaster Report as presented. Motion passed without objection.

Advised members regarding the establishment of the Department of MS Foundation Account, a 5013c which would allow corporations who won't or can't donate to the League's 5014c status to donate money to the Foundation. Advised that there would be a 3-person Foundation board of trustees comprised of the Department Commandant, Department Paymaster, and one elected member to be voted on later in the meeting.

Encouraged Detachments to ensure they are following the rules and guidance established by their Bylaws and Administrative Procedures and to rely on the Bord of Trustees/Directors for guidance.

Reminded all that elected and appointed officers must be current in the dues in order to be eligible to serve in the elected/appointed positions.

Commandant: Gave a short farewell message as his term in office was expiring today.

Sr. Vice Commandant: No report.

Jr. Vice Commandant: Reported on his visits to the Department's Detachments

Judge Advocate: No Report

Chaplain: No report.

Jerry Holt, SE Division National Vice Commandant

Discussed ongoing issues and efforts to address membership issues. Encouraged Detachments to elevate problems/issue to National via the Department.

Advised that Detachments can now pull their own rosters from the National website database portal. Stressed the importance of protecting Department/Detachment funds and recommended that someone other than the check signers have access to their organizational account to monitor funds. Discussed the difference between audits and financial reviews and encouraged the Department and Detachments to conduct regular reviews.

Johnny Baker MCL Past National Commandant

Informed members of the new MCL Veterans Service Officer (VSO) Program. The plan is that each Department have a trained and certified VSO. Training is available through online classes. Department VSOs will be volunteer positions. National has already hired a paid VSO to set up and administer the Program.

Advised members that a new Color Guard SOP is available at the National Web Site and encouraged all detachment to review it. Further advised that the Honor Guard SOP is being updated.

## Jr Past Department Commandant Cliff Addison

Encouraged members to seek out homeless veterans and help get them into the VA system.

Gave a presentation on preventing veterans' suicide. Noted that in one year 3,962 veterans between ages 18-34 committed suicide. Noted that 54% of veterans suffer from chronic pain and 33% suffer from PTSD-related substances and alcohol abuse. Also advised that veterans who do not seek VA care have a higher suicide rate. Encourage members to get involved and to offer help; noted that anyone can help prevent suicide.

Gave a presentation on the Department's planned 250<sup>th</sup> Marine Corps Birthday Ball, scheduled for 1 Nov 2025 in Jackson. Advised that registration is now open and encouraged member to register and to share information about the Ball as widely as possible.

## Dept Vice Commandant

Presented Detachment Recruiting Awards to Detachments 173, 1073, and 1450.

Presented individual Recruiting Awards to Larry Sullivan (1<sup>st</sup> Place), Ric Polleck (2<sup>nd</sup> Place), and to multiple, tied 3<sup>rd</sup> place award winners.

Department Commandant presented a Distinguished Service Award to outgoing Dept Judge Advocate Robert Hall for his service as Judge Advocate.

Paymaster briefed members on the proposed budget for FY 2026. Motion was made and seconded to accept the proposed budget. Motion passed without objection.

Following a discussion on the matter, a motion to allocate \$250.00 toward the purchase of a full-page ad in the National Convention Booklet was made and seconded. Motion passed without objection.

Member Ron Polk briefed members on state-wide Eagle Scout Awards. Detachments were encouraged to donate funds to the Department to help defray the costs associated with buying patches, certificates, and presentation folders. Further, he advised that he's seeking someone to assist and eventually take over the Department's Eagle Scout Awards program.

Past National Commandant Johnny Baker noted that National is looking to expand the Young Marine Program into south MS and that he was available to assist.
